The social parties constituting the National Employment Council for the Agricultural Industry in Zimbabwe (NECAIZ), which are the Zimbabwe Agricultural Employers Organisation (ZAEO), Zimbabwe Commercial Farmers Union (ZCFU), Zimbabwe Farmers Union (ZFU), Commercial Farmers Union (CFU) and Zimbabwe Agricultural Agro Dealers Employers' Organisation (ZAADEO) on the employers' side and the General Agriculture and Plantation Workers' Union of Zimbabwe (GAPWUZ), Horticulture, General Agriculture and Plantation Workers' Union of Zimbabwe (HGAPWUZ), Zimbabwe Horticulture Agro Industries and General Agriculture Workers Union (ZHAGAWU), and Progressive Agriculture and Allied Industries Workers' Union of Zimbabwe (PAAWUZ) on the employees' side, have agreed on the following provisions concerning minimum wages in the Agro sector effective 1st February 2025.

- 1. The minimum wage for the Agro subsector shall be increased by 5 percent from USD130.00 to USD137.00 payable in a component of 70% United States Dollars (USD) and a USD component of 30% convertible to the Zimbabwe Gold (ZWG) currency according to the prevailing interbank rate on the 20<sup>th</sup> day each month for which the wage is due, effective 1<sup>st</sup> February 2025.
- 2. Schedule A below provides the minimum monthly wages for the Agro subsector. The minimum wages provided in the schedule are effective 1 February 2025.
- 3. Notwithstanding anything contained in any collective bargaining agreement applying to the generality of the agricultural industry, and without derogation from any further allowances provided for in any such collective bargaining agreements, the Agro subsector has agreed to the minimum allowances referred to in Schedule B below, and these shall be binding on all employers and employees in the Agro subsector.
