Timber Subsector Minimum Wages Schedule as at 20th March 2024 at interbank bank rate of USD1:19,332.3989 effective 1st March 2024.

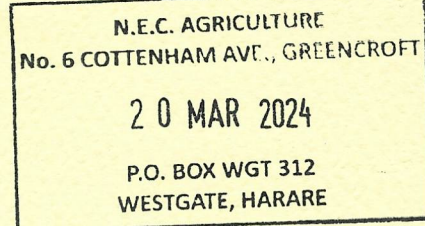
